CMC DESIGNATION

- Celebrate the members who have completed all elements and passed their Oral Assessment to become CMCs

CMC LONG SERVICE RECOGNITION

- 10, 15, 20, 25, 30, 35
- Since ICMCA did not hold an Awards Gala in 2022, we will recognize those individuals who hit their anniversary dates in either 2022 or 2023.
 - Will recognize certified members for their continued active status since the year they were initially awarded their CMC designation.

FELLOW CMC DESIGNATION

FCMCs demonstrate respect and integrity, showing excellence in:

- Recognition as an outstanding professional/academic, with a track record of producing innovation in their craft; and in doing so, has brought credit to the Certified Management Consultant designation and the management consulting profession.
- Provision of exceptional service to the profession through work in or on behalf of the Institute, other provincial or regional Institutes of Certified Management Consultants of Canada, and/or CAMC, and/or ICMCI.
- Notable contributions to the community at large, which brings credit to the Certified Management Consulting designation and the management consulting profession.

FCMCs have held the CMC designation for at least 10 years, OR, has at least 10 years of experience as a Management Consultant and has been awarded CMC designation. In rare cases, individuals worthy of FCMC may be considered with less than 10 years.
