- Reducing the overall complexity of the criteria, with greater emphasis and weighting to qualitybased selection practices, competency and capability demonstration.
- Assisting with establishing criteria standards, associated and relevant qualifications, and professional designations in appropriate categories.

- Striving towards greater consistency in government contracting practices and processes that recognize and incentivize quality and value and reducing a potential of perceived emphasis and preference for lowest cost as the driving factor or measure.
- Simplifying and replacing complicated and obtuse language with more concise and generally acceptable and understandable language.

### 3. What other topics are you interested in addressing with respect to contract simplification?

Other topics we would be interested in elevating with respect to contract simplification include, but are not limited to:

- Improved end-to-end procurement elapsed time (from invitation to bid to contract award), ensuring vendor eligibility and qualification across Canada (as CMC-Canada represents CMCs coast to coast to coast).
- Improved use and optimization of procurement methods such as standing offer agreements (and/or pre-qualified firms lists) to support and further allow for value building with industry and to achieve administrative efficiencies and effectiveness for industry and the Crown.
- Recognition of the relevant and appropriate designations for the procurement of professional management consultant services.

CMC-Canada, on behalf of its membership, would like to indicate a strong interest and support for participating on this working group and further supporting efforts of the Crown to achieve its objectives with respect to contract simplification.
