

Earn the CMC Designation

The Certified Management Consultant (CMC) designation is recognized by Provincial legislation across Canada. The CMC is the profession's only international certification mark, recognized in 50 countries. It represents a commitment to the highest standards of consulting and adherence to the ethical standards of the profession.

The Canadian Association of Management Consultants administers, and its provincial Institutes confer, the CMC designation in Canada.

The Certified Management Consultant designation (CMC) is a competency-based professional designation, which requires a candidate to demonstrate evidence of their knowledge and skills as a management consultant. Senior candidates are afforded credit for their experience and proficiency. Candidates are measured against the management consulting competency framework set by the International Council for Management Consulting Institutes (CMC-Global).

In a profession with few objective benchmarks there is only one unquestioned credential: the CMC designation. Those few who earn the right to call themselves Certified Management Consultants have attained what others aspire to -- a higher level of management consulting.

As a CMC and as a member of CMC-Canada, you can increase your value as a professional, expand your network and showcase your expertise to your clients and prospects. The CMC designation signifies peer accreditation and is recognized your initiative in continuing to develop your professional skills and willingness to adhere to a rigorous Uniform Code of Professional Conduct demonstrate a commitment to the profession.
